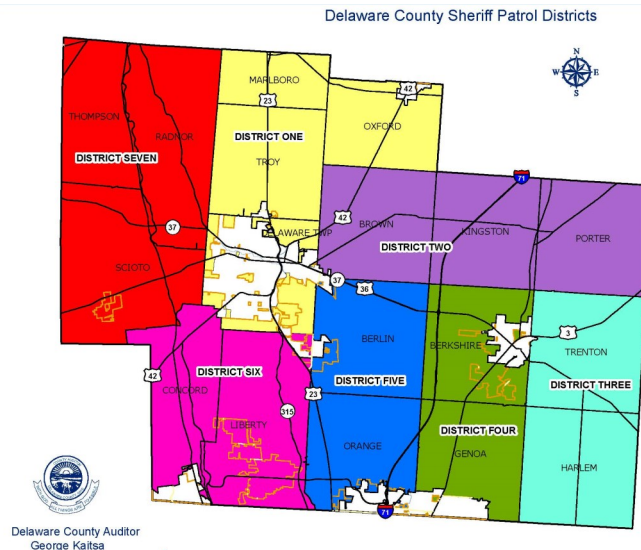

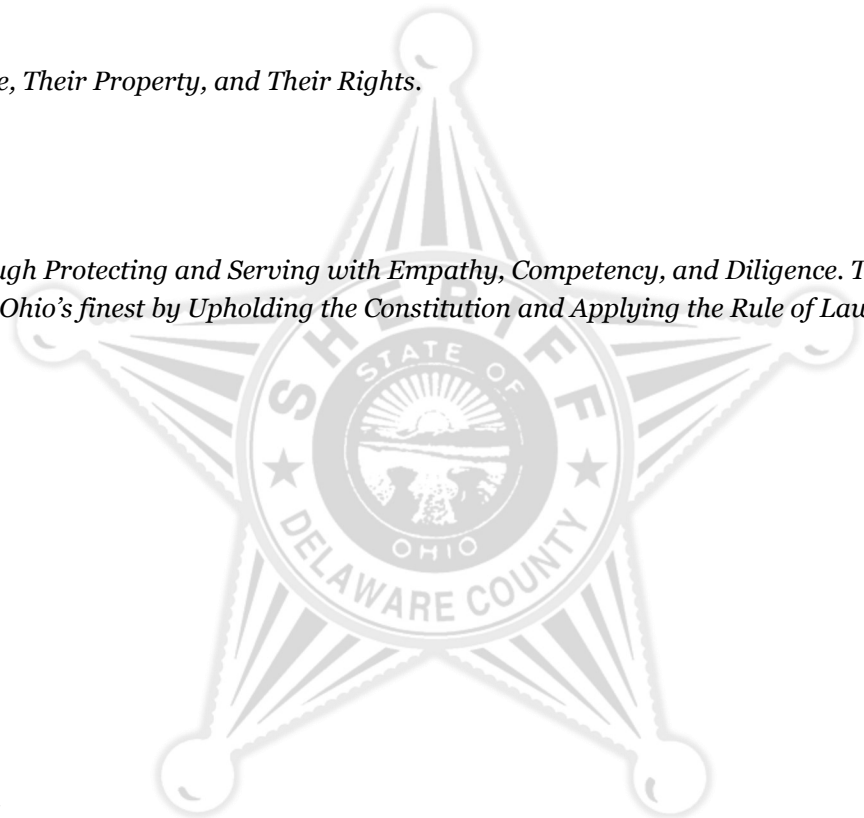

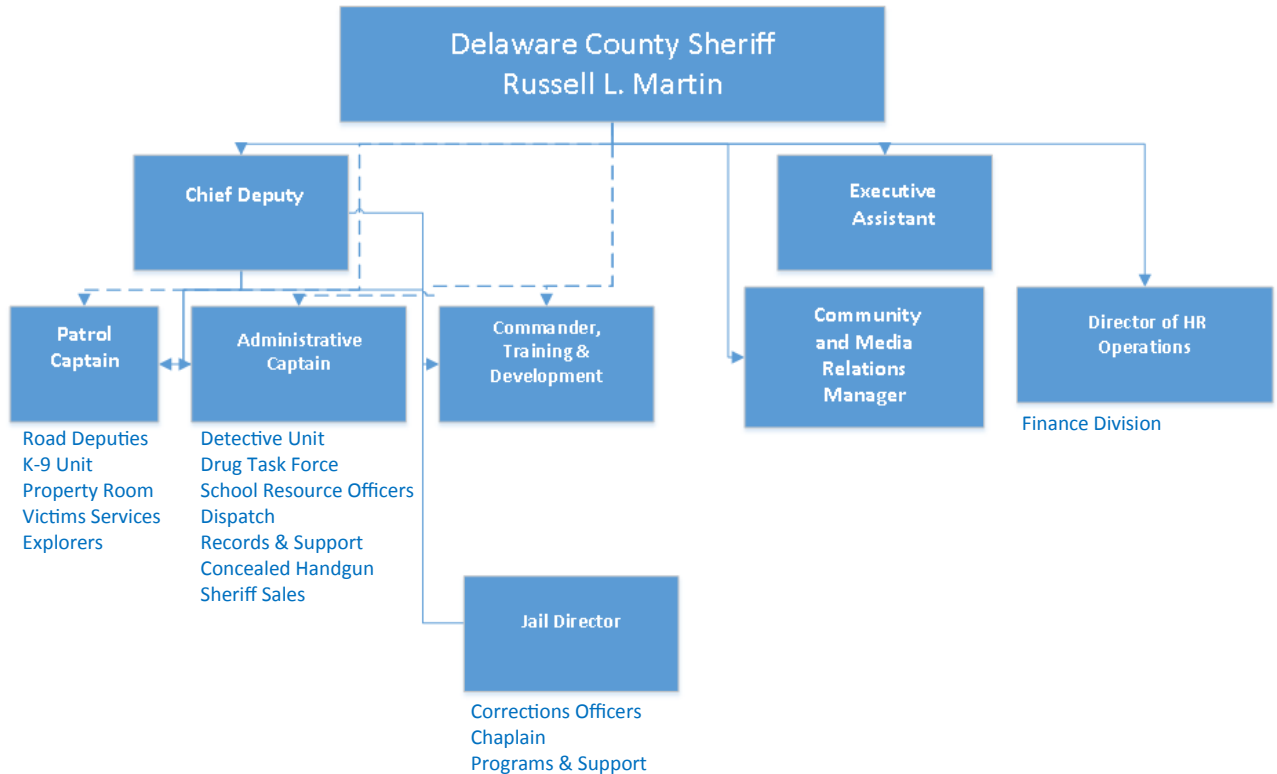

A new partnership was forged in 2015 between the Delaware Area Career Center and the Sheriff's Office with the addition of a new Commander position. The Commander is charged with running the law enforcement program at the Career Center and spearheading all training efforts for the Sheriff's staff. This shared resource is a cost-effective use of taxpayer dollars, and an innovative way to collaborate and meet multiple community goals.

Financials

The Delaware County Sheriff's Office is a tax-supported operation, with the majority of funding generated by local taxes. The Delaware County Commissioners allocate the necessary amount so that this Office meets the statutory requirements of a county sheriff's office.

In addition, the Sheriff's Office budget is supplemented by several other funding streams, including:

- ⇒ State and federal grants in support of programs, such as the Drug Task Force
- ⇒ Drug Seizure funds and OVI court fines, used for community drug education
- ⇒ Fees collected for the sole purpose of running the Concealed Handgun License program

The Sheriff's Office also contributes to Delaware County's general fund through other funding sources such as inmate charges, foreclosed property sales, and special duty cruiser fees, to name a few.

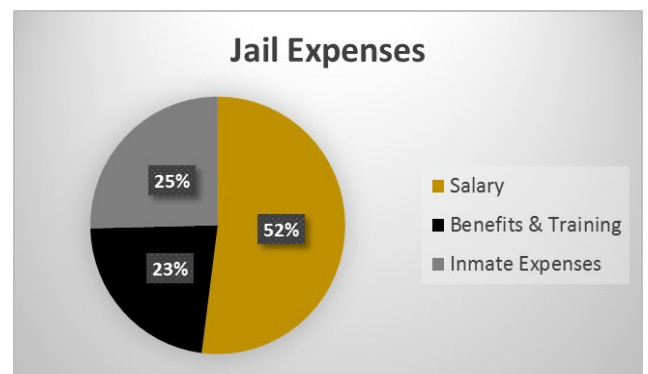
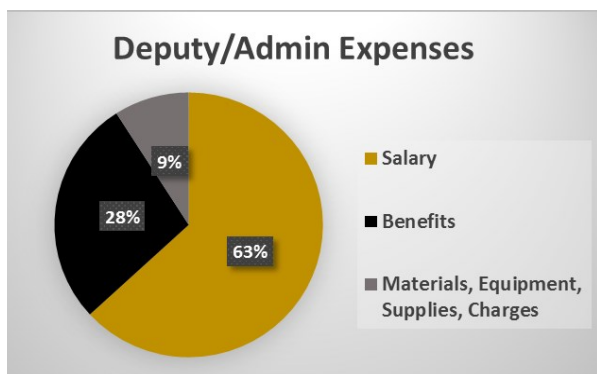

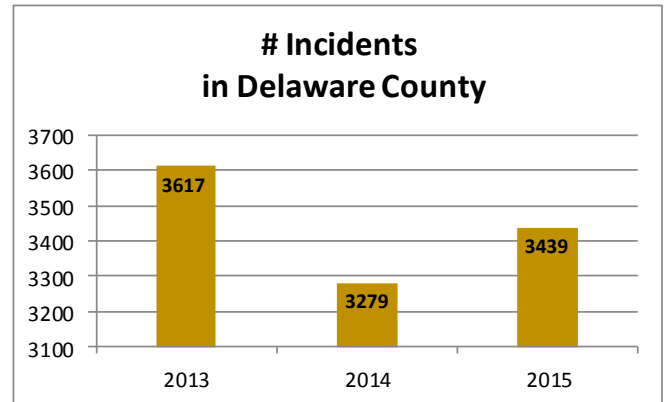


Crime Statistics

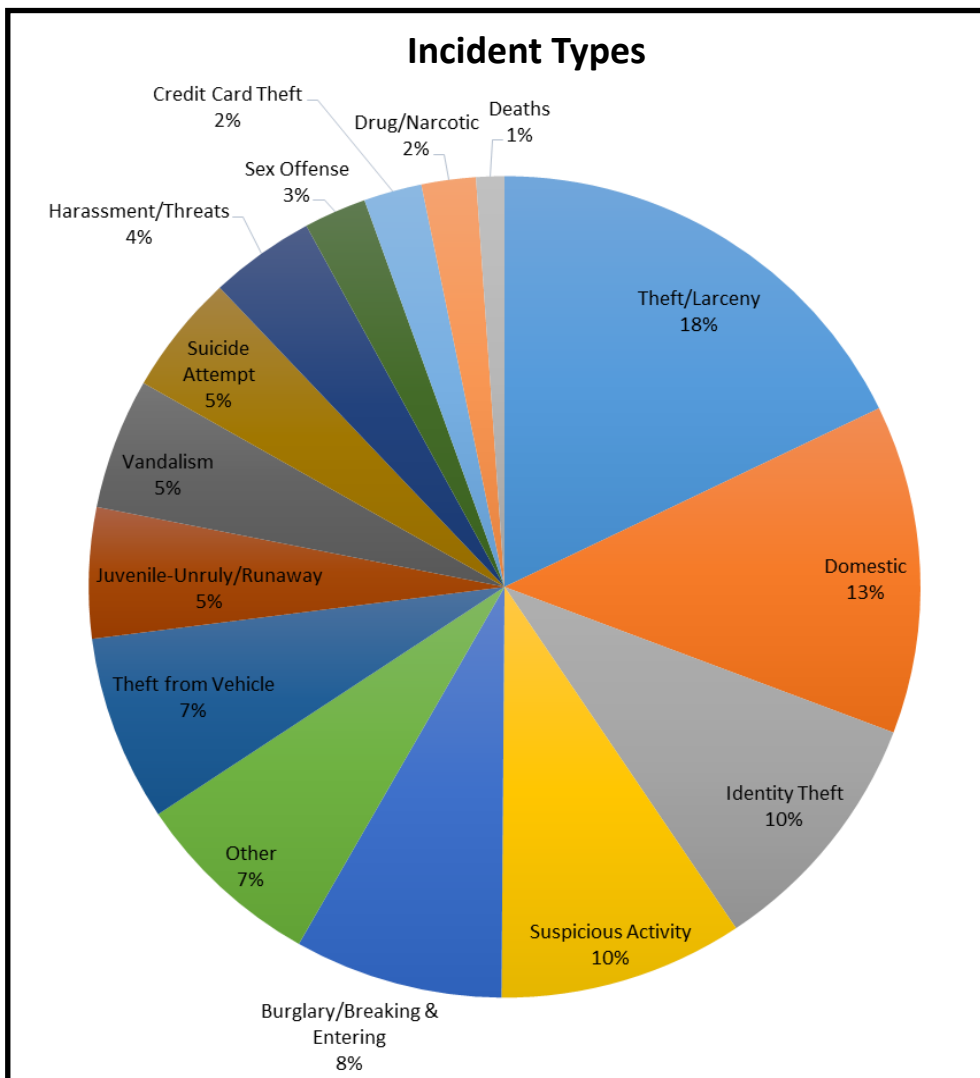

Patrol Division

The Patrol Division is likely the most visible aspect of the Sheriff's Office. These deputies are the frontline, and of the 6,335 reports taken in 2015, patrol deputies were typically first on scene. These trained professionals must constantly be on their toes, ready to respond to multiple unknown factors — and in quick fashion. While patrolling roadways, neighborhoods, and commercial and industrial areas, patrol deputies are not only enforcing the law, but are working to prevent crime as well. The Patrol Division covers the 415 square miles of unincorporated areas of Delaware County, but also has jurisdiction throughout the entire 459 square miles of the County.

Detective Division

Eight detectives, a criminal intel analyst, and a sergeant comprise this division. They work tirelessly to investigate criminal matters, oftentimes with multiple agencies, including our partners at the state and federal levels. These detectives are tasked with investigating felony crimes such as theft, burglaries, sexual assaults, homicides, suspicious deaths, among many others. Several notable achievements in 2015:

- ⇒ Former elementary teacher found guilty on 41 counts, including gross sexual imposition of juveniles.
- ⇒ Capture of suspect in an ATM theft, which led to convictions in a multi-county organized crime ring.
- ⇒ Burglary investigation resulted in catching the suspects in the act; led to solving multiple burglaries committed in Delaware and Licking counties.

Delaware Tactical Unit

This highly specialized unit is a multijurisdictional task force that operates under the authority of the Sheriff's Office. It was originally formed in the 1990s to help combat the devastation of crack cocaine. In 2015, the DTU was called upon and completed 20 missions, specifically:

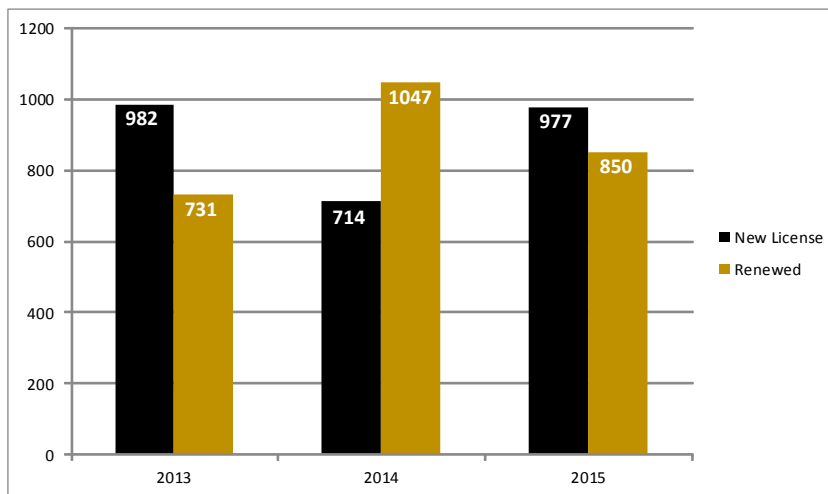

Drug Task Force

This multijurisdictional unit works around the clock to remove drugs and drug dealers off the streets. From gathering intel to going undercover, it can take months to build cases — but when drugs are confiscated and dealers are prosecuted, the long days and patience are well worth it. In 2015, the 9 members of the DTF worked 72 new cases from throughout Delaware County and into other geographic areas.

On August 4th, 2015, the 10,000th CHL license was issued from this Office, since the CHL law was passed in 2004.

School Resource Officers

This partnership with Delaware County public school districts emphasizes:

- ⇒ Prevention Education
- ⇒ Mentoring
- ⇒ Safety & Security
- ⇒ Enforcement

Programming ranges from kindergarten through high schoolers, and curriculum includes:

- ⇒ Drug and Alcohol Education
- ⇒ Gun Safety
- ⇒ Bullying and Self-Esteem
- ⇒ Violence and Self-Defense

School building staff are trained by SROs in active intruder scenarios to help reduce the amount of injury and loss of life should a violent intruder seek to harm one of our most precious resources: children and youth.



Support, Warrants & Records Units

Per the Ohio Revised Code, Ohio Sheriff's Offices are charged with the entry/deletion of stolen articles, wanted persons, and protection orders into the National Crime Information Center database. Records Clerks prepare all charges and citations for the court systems. The deputies in the Support division execute the delivery of warrants, writs, and protection orders, and provide for the safety and security of all court buildings.

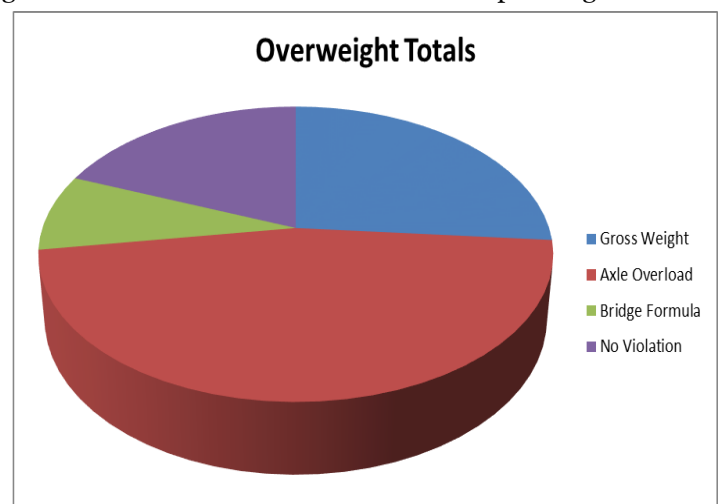

Victims' Services

The role of the Sheriff's Office Victim Advocate is to support victims of *misdemeanor offenses*, which include, but are not limited to:

- ⇒ Domestic Violence
- ⇒ Assault
- ⇒ Menacing/Aggravated Menacing
- ⇒ Intimidation of a Crime Victim

The victim advocate helps victims maneuver and understand the court and legal process, as well as their rights. The victim advocate also plays a pivotal role in linking the victim to community resources.

Sex Offender Registry

Sheriff's Offices in Ohio are charged with registering and tracking sex offenders, and notifying nearby neighbors when an offender locates to their area. An online database resource—eSORN—provides citizens access to this information, and residents can request to receive e-mail notifications.

Explorer Program

For youth ages 14 to 21, this program gives area youth/young adults the opportunity to explore a career in law enforcement. Explorers are often granted access to areas where only trained members of law enforcement are typically permitted. Explorers receive intense training and participate in a variety of drills and district competition, covering topics such as criminal investigations, search and arrest procedures, defensive weapons and tactics, first-aid and officer down training, and much more.

Internships

The Sheriff's Office provides two highly structured and hands-on internship programs :

- ⇒ 10-week long, 40 hours/week *paid summer college internship* for a student studying law enforcement/criminal justice or related field at a four-year accredited college/university.
- ⇒ 4-month long, 12 hours/week high school internship for four high school students either enrolled at the Delaware Area Career Center law enforcement program or who are participating in the Sheriff's Office Explorers program.

Corrections & Jail Programming

Built in 1988, the jail has a 286-bed capacity and is used to house suspects awaiting arraignment and trial, as well as for the short-term incarceration of criminals, up to 18 months. In 2015, the highest daily count of inmates was 282, with the lowest at 193. The additional statistics below provide a glimpse into the population demographics and programming for 2015.

Our philosophy is to treat all inmates with dignity and respect. Our goal is to provide each inmate with resources to help improve their situation, and to empower them to become contributing members of society upon their release. Here are some of the initiatives to help us reach that goal.

New Programs Implemented

- ⇒ Revamped Recovery & Re-entry (49 inmates participated, with 33 successful completions)
- ⇒ Father Factor (12 graduates to date)
- ⇒ Seeking Safety Groups
- ⇒ Moving Forward After Abortion
- ⇒ Addition of 7.5 hours/week to the existing faith-based programs, for a total of 11 hours/week

History

The year was 1808 and Delaware County had just been established, with one of the first orders of business being the election of a county sheriff. New Hampshire native, and former Revolutionary War Colonel Solomon D. Smith was elected Sheriff — with only 32 votes.

The few dirt roads that cut through Ohio's wilderness turned to pits of mud in the winter months, making many places inaccessible. Delaware's low crime rate matched its small, scattered population, and those crimes included letting geese or hogs run wild, selling bull meat, and loitering near a women's college.

When those first settlers arrived, all law enforcement at first followed the county sheriff style borrowed from England. The word sheriff originates from Old English, *shire reeve*, meaning an official who kept the king's peace in the countryside.

The first prison, a log structure measuring 12 x 24-feet, overlooked the Delaware Run, and was constructed for a total fee of \$128.75. Poorly built, prisoners would allegedly escape through the jail's roof, crow like a rooster and flee the scene. Despite this rough start,

matters improved, and in 1814 a larger and sturdier stone prison was finished. It was in turn replaced after a decade by a red, wooden barnlike building measuring almost 1300 square feet. Throughout the middle of the century, Delaware County used a two-story brick facility to house its inmates, until the 1870s when the more elegantly designed "old county jail" was put up at Central Avenue. As late as 1976, the Sheriff resided there with his wife, who as jail matron fed and cared for the inmates.

The current jail on US Highway 42 North was completed in 1988.

By 1930, Delaware's population stood at 26,000, and a total of 322 arrests were made.

By 1950, the population had reach 30,000, and arrests grew to 450, however, the Sheriff's Office resources totaled 3 deputies and 2 vehicles.

By 1967, the jail housed nearly 800 prisoners, and staff now included 5 deputies and 3 patrol cars. In 1972, an emergency medical service requiring 4 special cruisers was added, and the ranks swelled to 32.

And by the 21st century, 78 sworn deputies were patrolling a population of 156,000, making nearly 4,000 arrests annually.

Other highlights of the Sheriff's Office include ...

- 1967—establishment of the Mounted Deputies Unit
- 1973—dive team was formed to meet the need of rescue & recovery from numerous bodies of water
- 1977—the Mounted Deputies managed the construction of the Office's first Mobile Command Center, a minibus with radio communications, valued at \$15,000.
- 1993—K-9 Unit formed with Deputy Troy Petrie and K-9 partner Hasso.
- 1994—Delaware Tactical Unit was formed (see page 8).
- 1997—the Mounted Deputies started the annual *Shop with a Cop* program, which continues today.
- 2008—first-ever chaplain hired to support both inmates and sheriff's staff members.
- 2013—establishment of the Cold Case Unit, resulting in the 2014 discovery of a missing person from a 2004 case.

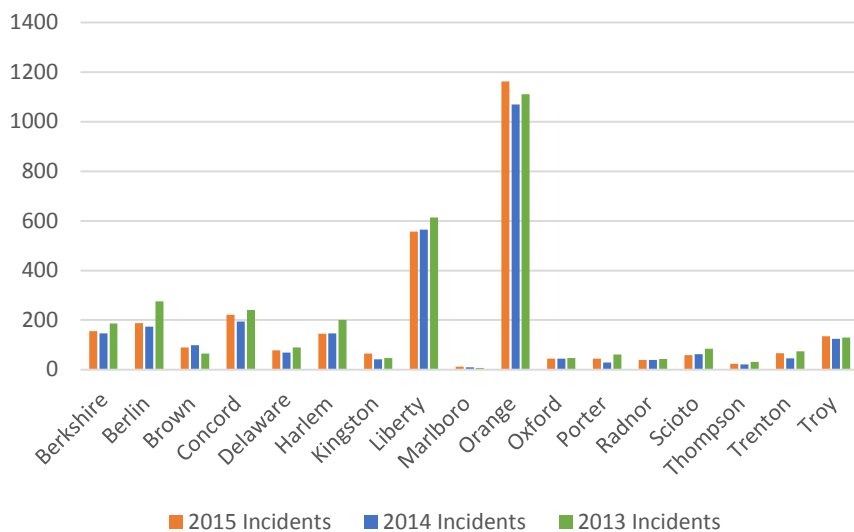

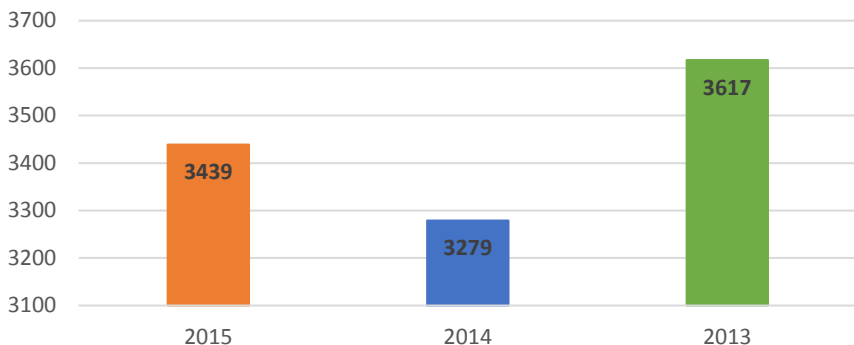
Breakdown of Berkshire Incidents
